

OFFICIAL RULES GMC ULTIMATE TAILGATE PACKAGE SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The GMC Ultimate Tailgate Package Sweepstakes (the "Sweepstakes") begins on August 16, 2019, at 12:00 a.m. Eastern Daylight-Saving Time ("EDT") and ends on December 29, 2019, at 11:59 p.m. Eastern Daylight-Savings Time ("EDT") (the "Sweepstakes Period"). Administrator's computer will be the official time-keeping device for the Sweepstakes. **Grand Prize Drawing event will take place on December 29, 2019 at Bank of America Stadium.**
